

2023 Highlights

In 2023, Sunday Assembly London marked a decade of fostering community, curiosity, and connection, highlighted by a vibrant 10th birthday celebration. Throughout the year, we explored themes of personal growth, creativity, and resilience, with events like 'Living Your Quest Life' which inspired attendees to pursue their passions and reconnect with their imaginations, and 'The Science of Poetry,' exploring the limits of language. We also embraced joy and movement with 'Dance is Radical' and celebrated diversity and inclusivity at 'We've Got Pride'. Sunday Assembly London's annual seasonal sing-along 'Yule Rock' also made its comeback. Our gatherings ranged from thought-provoking discussions on grief without God to light-hearted summer picnics, creating a space where everyone could find meaning, support, and a sense of belonging.

In total, we ran a programme of 22 events. These were:

5 February - Blowing Hot and Cold


The impact of fridges on diet, health, and climate, and their potential role in future energy crises.

Making poetry more accessible, including through a unique 'poetry coat.'

2 April - Once You Were a Dinosaur Snack

Explored human evolution through biological quirks, revealing our ancient animal past.

16 April - People and Places

How climate change influences relationships and how individuals can engage with the environment.

7 May - Goodbye Fury Friend

Addressed the often-overlooked grief of pet loss and the importance of discussing it openly.

21 May - Dance is Radical

Explored the significance of dance in culture and its potential for self-expression.

4 June - Guessed List

Provided tips on improving prediction skills in everyday life and geopolitics.

18 June - We've Got Pride

Explored what it means to go from shame to pride, and how joy and play can be tools for self-healing.

July - August

The community enjoyed outdoor picnics to build connections and spend time together.

3 September - Grief without God

Discussed approaches to grief, focusing on reclaiming ritual practices for contemporary needs.

17 September - Seeds of Change

The importance of preserving diverse seeds and their role in subverting colonial legacies.

1 October - Behind Closed Doors

Provided insights into life inside UK prisons and the importance of volunteering as an independent monitor.

15 October - Happy Together

Emphasised the role of happiness and kindness in personal and community well-being.

5 November - Aliens

What are the Chances? explored the scientific search for alien life and the evidence supporting it.

17 November - Smutty Letters

A selection of historical smutty letters highlighting the flirtatious art of past correspondence.

3 December - Dream Yourself Awake

The significance of dreams in human culture and their role in shaping memory and consciousness.

15 December

The annual Yule Rock sing-along raised money for Sunday Assembly and spread joy.

17 December - Solidarity & Community

Co-founders of the Museum of Homelessness shared their journey in creating a space to educate and advocate on homelessness issues. Sunday Assembly also held a Winter Market with makers, crafters and artists selling their homemade gifts, to raise money for Sunday Assembly.

Sunday Assembly International Conference - Awesome Fest

From the 7 - the 9th of July 2023, Sunday Assembly held its annual international conference in Brighton called Awesome Fest. It was a fantastic event with a wide range of speakers, workshops and socials. People attended from Sunday Assemblies in America including East Bay, Los Angeles, Nashville, Pittsburgh and San Diego and all over the UK including London, Brighton, Edinburgh, and Reading. It was a wonderful opportunity to meet, share, learn, socialise and have fun with the wider Sunday Assembly community.



Community impact

In addition to our assemblies, Sunday Assembly provides many activities for people to come together, share their passions, and have fun. These activities also provide many volunteering opportunities across these groups and beyond.

► Band and choir volunteering

The band and choir met regularly to rehearse and enable them to lead and support the communal singing at Assemblies.

► Other Interest Groups

Tea and TED

This online meetup continued allowing the community to come together in an inclusive and virtual space.

Facebook social group

The thriving Sunday Assembly Facebook social group enables community members to arrange and promote an array of ad hoc meet-ups based on the varied interests of the group.

Lunch club and Pub group

Following each assembly, volunteers invite community members to join them at either the pub or for an alcohol-free lunch to continue the conversation and community bonding.

Board Games Club

Led by community member Mitsky Shah, the club met after Sunday Assemblies in person to enjoy a game or two together.

Article Club

Led by community member Alistair Baker, the group meet monthly to review and discuss democratically selected articles.

The power of giving and receiving donations



► Putting the “Fun” in Fundraising

Roaring back from the lockdowns, Yule Rock was a smashing success, bringing hundreds of people together for a night of song and cheer. This success contributed substantially to our annual fundraising efforts, contributing £4,538 in profit. Even more importantly, Yule Rock was followed by a surge in attendance, providing a winter boost to our community spirit.

Gwawr Thomas, who heads up our Coordination Crew, organised a silent auction and raffle with prizes such as a Swing dance lesson, handmade candles, a singing workshop and a homemade Christmas Cake. A huge thank you to everyone who contributed prizes for others to enjoy.



► How our community comes together

Attendees: The success of Sunday Assembly hinges on the active involvement of our community. In 2023 we embraced this by running events to gather feedback from our community members to ensure their voices are not only acknowledged but also actively involved in shaping the future trajectory of Sunday Assembly for years to come.

Supporters: Financial support from our community is incredibly important to the future of Sunday Assembly so attention to existing and new regular donors will continue to be prioritised in the future.

Volunteers: As a volunteer-led organisation, our volunteers are integral to the success of Sunday Assembly - without them, we truly wouldn't be able to do what we do! Recruiting new volunteers and maintaining relationships with everyone who has been giving their time longer term has been a key consideration for the Board and Coordination Crew throughout 2023.

Principle risks and uncertainties

Community engagement identified community growth and venue consideration as two key areas for discussion in future strategy planning. Venue costs are the largest part of our budget. Both from an aesthetic point of view and financial perspective, the current attendance rates may be too low to support Sunday Assembly in Conway Hall in the long term.

Efforts in 2024 and beyond will target strategic development in these two areas. First, we will seek to identify communications strategy and other avenues for growing the size of the community both to increase the vibrancy of our assemblies and to better support costs through both regular and one-off donations. Second, we will conduct research into alternative venue possibilities as an alternative strategy if growth is not sufficient. The success of our community growth efforts as well as the availability of possible alternatives will determine the future course of Sunday Assembly London.

► The future is bright

Our community is the driving force behind the future of Sunday Assembly. To ensure that our governance, strategies, and the shaping of the organisation truly reflect our community, we actively engage in co-creating through community-centred events. Together, we strive for resilience and strength, knowing that any necessary changes are faced together.

Notes to the Accounts for the year ended 31 December 2023

1. Accounting policies

Policies relating to the production of the accounts

Basis of preparation and accounting convention

The accounts have been prepared on the accruals basis, under the historical cost convention, and in accordance with the Financial Reporting Standard 102, (effective 1st January 2016) and 'FRS 102 SORP (Statement of Recommended Practice for Accounting and Reporting by Charities) 2015, (as amended by the Bulletin issued in October 2018 and applicable to all accounting periods beginning on or after 1st January 2019), (The SORP), published by the Charity Commission in England & Wales (CCEW), effective January 2016, , and in accordance with all applicable law in the charity's jurisdiction of registration, except that the charity has prepared the financial statements in accordance with the FRS 102 SORP (Statement of Recommended Practice for Accounting and Reporting by Charities) 2015, (as amended by the Bulletin issued in October 2018 and applicable to all accounting periods beginning on or after 1st January 2019), (The SORP), in preference to the previous SORP, the SORP 2005, which has been withdrawn, notwithstanding the fact that the extant statutory regulations, the Charities (Accounts and Reports) Regulations 2008 refer explicitly to the SORP 2005. This has been done in accord with current best practices.

Going concern

Preparation of the accounts is on a going concern basis. The trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern.

Risks and future assumptions

The charity is a public benefit entity.

The directors actively review the major risks which the charity faces on a regular basis and believe that maintaining the free reserves stated combined with the annual review of the controls over key financial systems carried out on an annual basis will provide sufficient resources in the event of adverse conditions. The directors have also examined other operational and business risks which they face and confirm that they have established systems to mitigate the significant risks.

Recognition of liabilities and expenditure

A liability, and the related expenditure, is recognised when a legal or constructive obligation exists as a result of a past event, and when it is more likely than not that a transfer of economic benefits will be required in settlement, and when the amount of the obligation can be measured or reliably estimated. Liabilities arising from future funding commitments and constructive obligations, including performance-related grants, where the timing or the amount of the future expenditure required to settle the obligation is uncertain, give rise to a provision in the accounts, which is reviewed at the accounting

year-end. The provision is increased to reflect any increases in liabilities and is decreased by the utilisation of any provision within the period, and reversed if any provision is no longer required. These movements are charged or credited to the respective funds and activities to which the provision relates.

Volunteers

In accordance with the SORP, and in recognition of the difficulties in placing a monetary value on the contribution from volunteers, the contribution of volunteers is not included in the income of the charity.

However, the trustees value the significant contribution made to the activities of the charity by unpaid volunteers and this is described more fully in Note 4.

Fixed assets

The Charity held no fixed assets during this or the previous financial year.

Debtors

Debtors are measured at their recoverable amounts at the balance sheet date.

Financial instruments including cash and bank balances

Cash held by the charity is included at the amount held and counted at the year end. Bank balances, whether in credit or overdrawn, are shown at the amounts properly reconciled to the bank statements.

Pensions - defined benefit schemes

Due to Sunday Assembly not having any employees this is not something which the charity is required to have in place.

Fund accounting

Unrestricted funds are available for use at the discretion of the Directors in furtherance of the general objectives of the charity. There are no endowment funds.

2. Liability to taxation

The charity is exempt from tax on its charitable activities.

3. Winding up or dissolution of the charity

If upon winding up or dissolution of the charity there remain any assets, after the satisfaction of all debts and liabilities, the assets represented by the accumulated fund shall be transferred to some other charitable body or bodies having similar objects to the charity.

4. The contribution of volunteers

Sunday Assembly London continues to be a volunteer-led organisation. Its reliance on volunteers is at the heart of the charity and a true representation of the work done to provide opportunities to all. We do have two paid, part-time contractor roles: Producer and Bookkeeper. The Producer's main focus is leading the production of Sunday Assembly's core service - the assemblies on the first and third Sundays of the month.

Outside of this, the running of Sunday Assembly is managed by two volunteer teams. Firstly, the Board of Trustees, who have accountability for setting Sunday Assembly's strategic direction and ensuring it fulfils its charitable purpose and legal and compliance obligations. Secondly, the Co-ordination Crew, which is responsible for delivering Sunday Assembly's services including twice monthly Assemblies, Interest Groups, Choir, Community meetings, and fundraising activities.

5. Staff costs and emoluments

Sunday Assembly has not had any employees since 2019. The charity operates with a Producer who is a contractor and paid on a monthly basis.

6. Remuneration and payments to trustees and persons connected with them

No trustees or persons connected with them received any remuneration from the charity or any related entity. No employees received emoluments (excluding pension costs) in excess of £60,000 per annum.

14. The purposes for which the funds are used

Unrestricted and designated funds

One of the main uses for Sunday Assembly's unrestricted income is to put events on which aim to bring people together, to connect and make lasting relationships that eliminate loneliness and social isolation. We use our motto to live better, help often and wonder more to influence, inspire and excite our audience. All events, aside from our fundraising events, rely on the generosity of our audience so that we can continue doing what we do but also continue to build and evolve this charity so that we can reach out to more people. In 2023 we put an unrestricted £500 Faith and Belief Forum Community Award towards our regular venue hire costs (this does not appear in the tables, which focus on rested grants).

Restricted funds

The Sunday Assembly relies on the generosity of speakers, poets and other contributors, who give their time. We have only small budget for speaker expenses but in 2022 we received £900 in donations restricted for speaker's expenses; In 2023 we spent £463 of this.

15. Ultimate controlling party

The charity is under the control of its legal members. Every member of the charity is obliged to contribute such amount as may be required not exceeding £10 to the assets of the company in the event of its being wound up while he or she is a member, or within one year after he or she ceases to be a member.
